- 2. A member entitled to attend and vote is entitled to appoint a proxy to attend and vote instead of himself and the proxy need not be a member. Proxies in order to be effective must be received by the Company not later than Forty Eight (48) hours before the Meeting. Proxies submitted on behalf of Limited Companies, Societies, etc., must be supported by appropriate resolutions/authority, as applicable.

A person can act as proxy on behalf of Members not exc eding Fifty (50) and holding in the aggregate not more than 10% of the total share capital of the Company. case a proxy is proposed to be appointed by a Member holding more than 10% of the total share capital of the Company carrying voting rights, then such proxy shall not act as a prox or any other person or shareholder.

- 6. Relevant documents referred to in the accompanying Not and in the Explanatory Statements are open for inspection by the Members at the Company's Registered Office on all working days of the Company, during business hours up to the date of the Meeting.
- 7. Corporate Members intending to send their authorized representatives to attend the Meeting pursuant to Section 113 of the Companies Act, 2013 are requested t and to the Company, a certified copy of the relevant Board Resolution together with their respective specimen signauthorizing their representative(s) to attend and vote on their behalf at the Meeting.

For Members who have not registered their e-mail addresses, physical copies are being sent by the ermitted mode.
- 12. The Securities and Exchange Board of India (SEBI) has dated the submission of Permanent Account Number (PAN) by every participant in the securities market. Members holding shares in electronic form are, therefore, requested to submit their PAN to the Depository Participants with whom

they maintain their demat accounts. Members holding shares in physical form should submit their PAN to the Company.

13. E-Voting process

- I. The Company has provided 'remote e-voting' (e-voting from a place other than venue of the Annual General Meeting (AGM) facility through National Securities Depositary Limited (NSDL) as an alternative, for all members of the Company to enable m to cast their votes electronically, on the resolutions mentioned in the notice of the 25th Annual General Meeting of the Company dated 30th September, 2016. (the AGM Notice)
- II. The facility for voting through ballot / polling paper shall be made available at the AGM and the members attending the Meeting who have not cast their by remote e-voting shall be able to exercise their right at the Meeting through ballot pap r. The members who have cast their vote by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again.
- III. The remote e-voting period commences on 27^{th} September, 2016 (09:00 am) and ends on 29^{th} September, 2016 (5:00 pm). During this period members' of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date of 23^{rd} September, 2016 may cast their vote by remote e-voting. The remote e-voting module shall be disabled by NSDL for voting thereafter. Once the vote on a resolution is casted by the member, the member shall not be allowed to change it subsequently.
- IV. The Company has appointed Mr. Preyansh Shah, Proprietor of Preyansh Shah & Associates., a Practicing Company Secretary, as a Scrutinizer for con ucting the remote e-voting and the voting process at the AGM in a fair and transparent manner. E-voting is optional. In terms of requirement of the Companies Act, 2013 and the relevant Rules, the Company has fixed 23rd September, 2016 as the 'Cut-off Date'. The remote e-voting/voting rights of the shareholders / beneficial ers shall be reckoned on the equity shares held by them as on the cut-off Date i.e. 23rd September, 2016 only.

- (viii) Now you are ready for remote e-voting as Cast Vote page opens.
- (ix) Cast your vote by selecting appropriate option and click on "Submit" and also "Confirm" when prompted.

- (x) Upon confirmation, the message "Vote cast successfully" will be displayed.
- (xi) Once you have voted on the resolution, you will not be allowed to modify your vote.

- VIII. The voting rights of members shall be in proportion to their shares of the paid up equity share capital of the Company as on the cut-off date of 23rd September, 2016.

- XII. A person, whose name is recorded in the register of members or in the register of beneficial owners maintained by the depositories as on the cut-off date only shall be entitled to avail the facility remote e-voting as well as voting at the AGM through ballot paper.
- XIII. Mr. Preyansh Shah, Proprietor of Preyansh Shah & Associates, a Practicing Company Secretary has been appointed as the Scrutinizer for providing facility to the members of the Company to scrutinize the voting and remote e-voting process in a fair and transparent manner.
- XIV. The Chairman shall, at the AGM, at the end of discussion on the resolutions on which vo ing is to be held, allow voting with the assistance of scrutinizer, by use of "Ballot Paper" or "Polling Paper" for all those members who are present at the AGM but have not cast their votes by availing the remote evoting facility.
